AFTER WHICH, THE TENANT WILL HAVE TO LEAVE THE PREMISES IMMEDIATELY AT THE REQUEST OF THE LANDLORD.

THE LANDLORD MAY BRING PROSPECTIVE TENANTS TO VIEW THE PREMISES FROM TIME TO TIME AND WILL GIVE NOTICE OF SUCH VISITS YOUR ASSISTANCE IN THIS REGARD WOULD BE APPRECIATED.

- ⌚ PLEASE KEEP COOKER CLEAN, ALSO CLEAN THE TOASTER, KETTLE, MICROWAVE, PLEASE CONSIDER THE OTHER PEOPLE IN THE APARTMENT WHO WILL USE THESE AFTER YOU
- ⌚ THE BATHROOM HAS TO BE KEPT CLEAN FOR THE HEALTH OF THE OTHER OCCUPANTS
- ⌚ DO NOT DISPOSE OF ANY UNSUITABLE MATERIALS IN THE TOILETS, OTHERWISE THE SEWAGE PIPES MAY BLOCK AND THE TENANTS WILL HAVE TO PAY FOR FREEING THEM. PLEASE USE A SHOWER MAT IN THE SHOWER AT ALL TIMES.
- ⌚ PLEASE READ THE INSTRUCTIONS BEFORE USING THE WASHING MACHINES. CLEAN THE FILTER EVERY TIME IT IS USED.

- ⌚ KEEP THE GARDEN IN GOOD ORDER, NO B.BQ'S, OR FURNITURE OUTSIDE

- ⌚ ALL RENT IS DUE ON THE DATES ADVISED TO YOU WHEN YOU MOVED IN, IT IS THE TENANTS DUTY TO ENSURE THE LANDLORD IS PAID IN FULL ON ALL DUE DATES. . IF CHARGES FOR LATE PAYMENT OF RENT ARE UNPAID THEY WILL BE DEDUCTED FROM YOUR DEPOSIT.

WHEN VACATING THE APARTMENT THE TENANTS MUST LEAVE THEIR BEDROOMS CLEAN INCLUDING WINDOWS, FLOORS AND SHELVES.

THE KITCHEN FLOOR, WINDOW SILLS, WINDOWS, CUPBOARDS, SHELVES, FRIDGE, COOKER, MICROWAVE, SINK, WALLS AND FURNITURE CLEAR OF ALL MARKS, BATHROOM FLOOR, WINDOW SILLS AND WINDOW, SINK, TOILET, SHOWER TRAY AND PLUG HOLE FREE OF DEBRIS,

PLEASE MAKE A LIST AND DIVIDE JOBS TO BE DONE BY EACH TENANT AND IT WILL TAKE VERY LITTLE TIME TO FINISH CLEANING THE APARTMENT
